The Roadmap on Carcinogens is a pan-European initiative that brings together organisations and individuals in the fight against work-related cancers. Among the partners that have committed to be active and take a leading role in this programme to prevent exposure to carcinogens in the workplace is also the Ministry of Labour, Family, Social Affairs and Equal Opportunities of the Republic of Slovenia.



European Week Against Cancer (EWAC) is an initiative of the Association of European Cancer Leagues (ECL), which brings together cancer organisations, health advocates, civil society groups and policy makers in an effort to raise awareness about the importance of cancer prevention and care for cancer patients.

European Cancer Week takes place every year between 25 and 31 May, culminating in World No Tobacco Day on 31 May.

Exposure to carcinogens threatens the general health and quality of life of workers and affects their workplace attendance and productivity. Cancer not only causes suffering for the individual, but also has a major impact on society. The direct cost of exposure to carcinogens in the workplace in Europe is estimated at €2.4 billion per year. When healthcare costs and lost productivity are taken into account, the estimated amount rises to between four and seven billion euros per year (RIVM, 2016).

As many as 53 % of work-related deaths in the EU are linked to exposure to carcinogens at work (OSHwiki). It is estimated that nearly 80,000 people die each year in the EU from occupational cancer. In addition, more than 120,000 people are diagnosed with occupational cancer each year. Diagnosis is often made several years after exposure, as the period from exposure to cancer can be very long. The worker may therefore already be retired when the disease appears.

The seminar will present for the first time to the Slovenian public the results of the Workers' Exposure to Cancer Risk Factors in Europe (WES) survey, which was carried out by the European Agency for Safety and Health at Work (EU-OSHA) in Germany, Ireland, Spain, France, Hungary and Finland in 2023. The survey provides data and

findings on the likely exposure of workers during their last working week to 24 known cancer risk factors. The survey is based on the methodology of the Australian study and the OccIDEAS tool.
